

## INSTRUCTIONS

- The candidates must bring the call letter alongwith original photo identity proof (such as PAN Card/Passport/Driving License/Voter's Card/Bank Passbook with photograph/Photo embossed Credit Card/Aadhar Card with a photograph) as well as a photocopy and original fee payment receipt challan. The call letter along with the original fee payment receipt challan and photocopy of photo identity proof duly stapled together should be submitted to the invigilator in the examination hall failing which the candidate will not be permitted to appear for the test. Do not forget to write your Registration No. and Roll No. on the original fee payment receipt challan and photo copy of Photo identity proof. Candidates should put their Left Thumb Impression and sign in the respective space provided on the call-letter in the presence of the invigilator.
- A handout giving information about the type of test you will be taking is available on the Bank's website. Please download the booklet and study it carefully.
- You must bring a ball point pen with you.
- Your admission to the examination is strictly provisional. Before coming for the examination, please ensure that you are eligible according to the eligibility criteria stipulated in the Advertisement. If you are not eligible, your candidature will be cancelled at any stage.
- Candidates must report at the examination venue before the time of the examination as printed on this call-letter. Candidates arriving late will not be permitted to enter the Examination Hall.**
- Use of books, notebooks, calculators, watch calculators, pagers, **mobile phones** etc. is not permitted in this examination. Candidates are advised not to bring any of the banned items including mobile phones/pagers to the venue of examination as arrangement for safekeeping cannot be assured. Any candidate found resorting to any unfair means or malpractice or any misconduct while appearing at the examination including giving/receiving help to/from any candidate during the test will be disqualified.
